# **Privacy Policy**

This Privacy Policy ("Policy") applies to mytcoat.com, and Aadvantage Panels & Fence DBA MyTCoat ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include mytcoat.com. The Company's website is a new, information, and product catalog site. By using the Company website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

#### **Sharing Information with Third Parties**
